Michael Schwartz, founder of Trial Advocacy Group, LLC, is a trial attorney with 165 jury trials to verdict. A frequent lecturer on trial advocacy skills to groups across the country, Mr. Schwartz has, for more than a decade, spoken at the State Bar of California's annual meeting and provided instruction for the Los Angeles County Bar Association's Trial Advocacy Project (the "TAP Program"), where civil attorneys learn how to try criminal cases and serve as pro bono prosecutors.
